to determine to public record a history of incremental measures for augmentations and improvements so that dedicated commitment to City, Province and Country, to Nature, to long enduring Heritage be given first priority for the great implicit culture locally devised with Mind and Hand to the gradual growth of City, Industry, Economy from the Heritage of the strength and cooperation of individuals to Society whereby cooperative procedures implicit and overt stay the foreign externally found invocations of undeterminable advances in anticipation of detriments to established arrangements in community, entities, interests, and practice.
